COUNCILMEMBER LAWSON STATED THAT SHE ATTENDED THE SENIOR CENTER HUB MEETING, AND THEY DON'T HAVE THE FUNDING TO HIRE A MANAGER. SHE STATED THAT THEY ASKED IF THE CITY MIGHT BE INTERESTED IN CONTRIBUTING ADDITIONAL FUNDING. COUNCILMEMBER LAWSON STATED THAT SHE INFORMED THEM THAT WE ARE ON A BIENNIAL BUDGET AND FUNDING IS SET THROUGH THE END OF 2016.

COUNCILMEMBER FOSTER STATED THE HE IS RESIGNING FROM HIS COUNCIL POSITION AS OF TODAY.

COUNCILMEMBER PIFER STATED THAT THE ORDINANCE FOR UNLAWFUL USE OF PUBLIC PROPERTY WAS WELL RECEIVED AMONG THE CITIZENS AND LOCAL AGENCIES.

COUNCILMEMBER BIRCH STATED THAT HE WENT TO THE DOMINION MEADOWS ATHLETIC ASSOCIATION MEETING. HE STATED THAT THEY ARE DOING GOOD FOR NOW, BUT THEY ARE WAITING FOR THE WATER BILL.

MAYOR JANKE HANDED OUT AN INFORMATIONAL PAMPHLET FROM THE NE TRI COUNTY HEALTH DISTRICT. THEY HAD DONE A SURVEY STATEWIDE AND THE TWO KEY HEALTH ISSUES BOIL DOWN TO ECONOMIC DEVELOPMENT AND MENTAL HEALTH. HE STATED THAT THE CITY WILL NO LONGER BE OFFERING FLU SHOTS FOR FREE TO EMPLOYEES WHEN THEY CAN GET IT DONE ON THEIR OWN AND HAVE IT PAID BY THE INSURANCE. MAYOR JANKE STATED THAT HE IS EXPLORING THE ISSUE OF A BAN ON FIREWORKS OR SOME FURTHER RESTRICTIONS. MAYOR JANKE STATED THAT HE WILL BE GONE APRIL 30 – MAY 6, BUT AVAILABLE BY CELL PHONE. HE STATED THAT HE ATTENDED THE TREE PLANTING FOR NATIONAL CRIME VICTIMS WEEK AT RURAL RESOURCES. HE REPORTED THAT LOGGING HAS BEGUN AT CRYSTAL FALLS. MAYOR JANKE ANNOUNCED THAT HE IS GOING TO RUN FOR MAYOR.

AS THERE WAS NO FURTHER BUSINESS TO COME BEFORE THE COUNCIL, COUNCILMEMBER KYLE MOVED AND COUNCILMEMBER BERGIN SECONDED THE MOTION TO ADJOURN THE MEETING.
