**SECTION 1:**

A fee of ~~\$350 (three hundred fifty dollars)~~ **\$750 (seven hundred and fifty dollars), plus hourly rate if application is more complicated**, shall be charged for each application requesting an annexation to the City of Colville.

**SECTION 2:**

Resolution No. 14-12 is hereby repealed in its entirety.
