**WHEREAS**, as provided by RCW 35.79.010, it is recognized that owners of an interest in any real estate abutting upon any street or alley who may desire to vacate the street or alley, or any part thereof, may petition the legislative authority to make vacation; and

**WHEREAS**, it is recognized that the public in general benefits from careful evaluation of a request to vacate; and

**WHEREAS**, it is also fair and appropriate that owners share in a portion of the costs associated with staff review and evaluation; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Colville, Washington, that the following fee be established:

**SECTION 1:**

A fee of \$150 (~~one hundred fifty dollars~~) **\$350 (three hundred and fifty dollars)** shall be charged for each application requesting the vacation of a street or alley, **or altering a subdivision.**

**SECTION 2:**

Resolution No. 15-12 is hereby repealed in its entirety.

This Resolution shall take effect and be in full force January 1, 2019.
